SECTION VII: PREVENTIVE MEASURE

PERSONAL PROTECTIVE EQUIPMENT / ENGINEERING CONTROLS

Wear rubber or other impervious gloves and splash goggles. Provide good general ventilation. Local exhaust ventilation may be necessary for some operations. If exposure limits (see Section II) can not be maintained by ventilation, use of a NIOSH approved respirator suitable for the conditions of use and chemicals in Section II should be considered.

LEAK AND SPILL PROCEDURE: Small spills of one gallon or less may be flushed with plenty of water to sanitary sewer system (If permitted by local sewer regulations). Dike and contain large spills with inert material and transfer liquid to containers for recovery or disposal. Keep spill out of storm sewers and waterways.

WASTE DISPOSAL METHOD: Assure conformance with regulations.

HANDLING PROCEDURES: Do not get in eyes, on skin or clothing. Avoid breathing product mist. Do not swallow. Use with adequate ventilation. Wash thoroughly after handling.

STORAGE REQUIREMENTS: Keep container closed when not in use. Do not freeze. Do not store above 49°C (120°F). Do not mix with other chemicals. Keep out of reach of children.

SPECIAL SHIPPING INFORMATION: Not regulated. Shipping Description: Non-Hazardous Products

SECTION VIII: FIRST AID MEASURES

EYES: Flush eyes with water for at least 15 minutes. Remove contact lenses. Get medical attention.

SKIN: Remove contaminated clothing and shoes. Flush skin with water for at least 15 minutes. Get medical attention. Wash contaminated clothing before reuse.

INGESTION: Do not induce vomiting. Drink one or two glasses of water to dilute product. Get medical attention. Do not give anything by mouth to an unconscious person.

INHALATION: In case of respiratory irritation, move person to fresh air. Get medical attention immediately.
