SECTION VII: PREVENTIVE MEASURE

PERSONAL PROTECTIVE EQUIPMENT / ENGINEERING CONTROLS

Natural rubber or other impervious gloves are recommended for frequent or prolonged skin contact. Safety glasses or splash goggles are recommended to prevent eye contact. Provide good general ventilation. Local exhaust ventilation may be necessary for some operations.
