SECTION VII: PREVENTIVE MEASURE

PERSONAL PROTECTIVE EQUIPMENT / ENGINEERING CONTROLS:

Use of gloves and eye protection not required with intended use. Provide good general ventilation. Local exhaust ventilation may be necessary for some operations.

LEAK AND SPILL PROCEDURE: Small spills of one gallon or less may be flushed with plenty of water to sanitary sewer system (If permitted by local sewer regulations). HANDLING PROCEDURES: Avoid contact with eyes. Avoid prolonged or repeated skin contact with undiluted product. Do not swallow. Avoid breathing product mist. Do not mix with sodium hypochlorite (bleach) or other household chemicals.
