### Letter of Guarantee: **ACID BLEND FP**

Spartan Chemical Company, Inc., as the manufacturer of Acid Blend FP, guarantees that this product is safe and effective for use in food processing plants, including federally inspected facilities, when used as directed on the product labeling and as directed below in this letter. When used in this manner this product will not adulterate food product or create unsanitary conditions. When requested by the Canadian Food Inspection Agency (CFIA), Spartan Chemical Company, Inc., will provide all supporting documents to demonstrate that the product is safe and/or suitable for use as intended.

**Acid Blend FP: Complies with the Following USA Requirements:**

- Complies with the Federal Food, Drug and Cosmetic Act.
- Conforms to Food Safety and Inspection Service (FSIS)'s "**Sanitation Performance Standards Compliance Guide**"
- Meets the profile of USDA's former "A3" Acid cleaners for use in all departments.

Before using Acid Blend FP, food products and packaging materials must be removed from the area or carefully protected. After using this product, surfaces must be thoroughly rinsed with potable water.

**Directions for use:**

**Acid Rinse:** Drain high alkaline-based detergent and rinse with water. Use Acid Blend FP at 1.6 ml per liter of water. Circulate for 15 minutes at 10-60° C. Drain the system and rinse with potable water. Sanitize before use.

**Initial Passivation:** Drain high alkaline-based detergent and rinse with water. Use Acid Blend FP at 63 ml per liter of water. Circulate for 20 minutes at 49° F. Drain the system and allow to air dry. *The tank must dry completely in order to successfully achieve passivation.* Rinse with potable water. Sanitize before use.

**Re-Passivation:** Drain high alkaline-based detergent and rinse with water. Use Acid Blend FP at 16 ml per liter of water. Circulate for 30 minutes at 49° C. Drain the system and allow to air dry. *The tank must dry completely in order to successfully achieve passivation.* Rinse with potable water. Sanitize before use.

**Clean-in-Place /Pasteurizer Systems** – Mix 16-48 ml Acid Blend FP per liter of water. Circulate through system. Rinse thoroughly with cold/hot potable water. Sanitize before use.

**General Cleaning (yeast tanks, egg graders, etc.)**-Mix 16 - 48 ml Acid Blend FP per liter of water. Circulate thru the system. Rinse thoroughly with cold/hot potable water. Sanitize before use.

Carefully read and follow all statements on the labeling and Safety Data Sheet while using this product.
