Letter of Continuing Guarantee: **FREEZER CLEANER FP**

Spartan Chemical Company, Inc., as the manufacturer of Freezer Cleaner FP, guarantees that this product is safe and effective for use in food processing plants, including federally inspected facilities, when used as directed on the product labeling and as directed below in this letter.

When used in this manner this product will not adulterate food product or create unsanitary conditions.

Freezer Cleaner FP is a cleaner designed for use on floors and walls in subfreezing temperatures. This product is not to be used for food contact surfaces. When requested by the Canadian Food Inspection Agency (CFIA), Spartan Chemical Company, Inc., will provide all supporting documents to demonstrate that the product is safe and/or suitable for use as intended.

Freezer Cleaner FP Complies with the Following USA Requirements:

- Complies with the Federal Food, Drug and Cosmetic Act.
- Conforms to Food Safety and Inspection Service (FSIS)'s "**Sanitation Performance Standards Compliance Guide**"
- Meets the profile of USDA's former "A5" "Freezer floor and wall cleaners".

Before using Freezer Cleaner FP, food products and packaging materials must be removed from the area or carefully protected. When used in areas with subfreezing temperatures, potable water rinsing is not required following use provided that the solution and solubilized soil are effectively removed by wiping or wet vacuuming.

Directions for use: Suggested starting point dilutions for freezer cleaning applications:

-23° C to -29° C 3:1 (3 parts Freezer Cleaner FP to 1 part water)

-18° C to -23° C 2:1 (2 parts Freezer Cleaner FP to 1 part water)

-12° C to -18° C 1:1 (1 part Freezer Cleaner FP to 1 part water)

Actual dilutions can vary due to soil load, substrate and mode of application.

DO NOT RINSE. Remove soiled solution with wet vac, squeegee or dry cloth. Do not use on food contact surfaces.

Carefully read and follow all statements on the labeling and Safety Data Sheet while using this product.
