# Letter of Guarantee: SPARCLEAN DELIMER [55]

Spartan Chemical Company, Inc., as the manufacturer of SparClean Delimer [55], guarantees that this product is safe and effective for use in food processing plants, including federally inspected facilities, when used as directed on the product labeling and as directed below in this letter. When used in this manner this product will not adulterate food product or create unsanitary conditions. SparClean Delimer [55] is an acid based lime and deposit remover for use in automatic dishwash machines, food processing washing machines and other acid resistant food contact surfaces.

When requested by the Canadian Food Inspection Agency (CFIA), Spartan Chemical Company, Inc., will provide all supporting documents to demonstrate that the product is safe and/or suitable for use as intended.

### SparClean Delimer [55]: Complies with the Following USA Requirements:

- · Complies with the Federal Food, Drug and Cosmetic Act.
- Conforms to Food Safety and Inspection Service (FSIS)'s "Sanitation Performance Standards Compliance Guide"
- Meets the profile of USDA's former "A3" Acid cleaners for use in all departments.

Before using SparClean Delimer [55], food products and packaging materials must be removed from the area or carefully protected. After using this product, surfaces must be thoroughly rinsed with potable water.

#### **Directions for use:**

- 1. Drain and clean out dish machine.
- 2. Set machine dispenser to the DELIME setting or cycle.
- 3. Close drain valve and fill tanks with hot water.
- 4. Add SparClean Delimer at 31-63 ml per liter of water.
- 5. Allow machine to run until lime deposits can be brushed or flushed away.
- 6. Rinse away residual lime deposits and drain tank.

**7.** Set dish machine to RUN setting and complete a wash cycle with potable water to remove product residue before returning dish machine to use.

**8.** For excessive lime buildup pour 2 to 4 liters of SparClean Delimer into wash tank and allow machine to run on the DELIME cycle.
