Directions for use:

For normal odor and smoke neutralization: Remove gross source of malodors such as ashtrays. Adjust spray nozzle for finest mist. Lightly mist upper portions of the room near ceiling. For fire-damaged areas: Adjust spray nozzle for finest mist. Apply directly to damaged or burnt surfaces wherever possible. Lightly mist upper portions of the room near ceiling.
